**AGREEMENT:**

Renter agrees to the following terms and conditions to rent a Aerotech Aviation aircraft.

1. To not make any flight for which they are not fully trained and qualified and to be acquainted with and abide by all laws, rules and regulations as required by Aerotech Aviation (here after referred to as Aerotech), insurance requirements, and FAA, Federal, State and local agencies and that they understand that violation of said regulations shall be deemed conclusive evidence of negligence on their part insofar as it shall affect their responsibility for damage to the Aerotech aircraft while it is in their possession.
2. Aircraft scheduled for more than six hours will be subject to a daily minimum time of two hours.
3. To notify Aerotech Aviation 24 hours in advance of any intent to cancel a scheduled flight, unless the cancellation is due to weather or an extreme emergency. Failure to properly notify Aerotech Aviation will result in a charge in full for the time Aerotech Aviation is not able to reschedule for both the aircraft and instructor.
4. To not permit any other person to act as pilot in command and to not allow nor give instruction in any Aerotech Aviation aircraft except by a Aerotech Aviation authorized flight instructor.
5. To return the aircraft at the end of the scheduled time, unless weather or an emergency has caused a delay. If such delay were to occur, the renter agrees to immediately contact Aerotech Aviation and inform them of the delay.
6. To assure the safety and security of the aircraft by making certain it is properly secured in accordance with Aerotech Aviation procedures, that the aircraft will be properly parked, secured to the ground, doors and windows locked, and any other device for securing the aircraft is used.
7. To hanger the aircraft at their own expense where it appears reasonably necessary to ensure the safety of the aircraft when away from the home base and to pay for any hanger, tie-down, landing, or any other airfield fee which may be assessed.
8. To operate the aircraft on hard paved surfaces only, unless a forced or emergency landing is required.
9. To file a FAA flight plan for any flight greater than 50 NM from U42.
10. To have all repairs preauthorize or the renter may be held responsible for the cost of the repair.
11. To have received a flight check by an approved Aerotech Aviation flight instructor in the type of aircraft to be

flown.

12. Payment is due at the time the aircraft is returned according to the time expired on the hobbs meter or in the event of a malfunctioning hobbs meter, 1.1 times the tach and renter agrees to allow Aerotech Aviation to bill the bank card on file for any unpaid balances, if late, interest will accrue at 18% per annum. I understand that my credit card information will be stored to be used upon request or to pay any past due invoices.
13. To be solely liable for and shall indemnify and hold Aerotech Aviation and Fly Boys LLC, the owner, harmless for all fines, penalties and forfeitures imposed for violations of any applicable Federal, state, Municipal or other statute, law, ordinance, rule or regulation while the aircraft is held, used, operated or flown under this agreement.
14. To defend, indemnify and hold harmless Aerotech Aviation and Fly Boys LLC from and against any and all losses, liabilities, damages, injuries, claims, demands, costs and expenses arising out of or connected with the possession or use of the aircraft during the rental term, including, but not limited to any and all claims of or liabilities third parties arising out of the abandonment, conversion, secretion, concealment or unauthorized sale of the aircraft by the renter or the confiscation of the aircraft by any government authority or illegal or improper use of said aircraft and that neither Aerotech or Flyboys LLC has any liability for any consequential damages suffered by them or by their passengers as a result of any malfunction of the aircraft of equipment.
15. If for any reason the aircraft is abandoned away from the home base, charges for the return of the aircraft to the home base will be billed and that the renter will be obligated to pay for such expenses.
16. Renter will reimburse Aerotech Aviation for any expenses incurred by Aerotech Aviation through damage to the aircraft and loss of income caused by any action or failure to act or the action of any agents and persons under their supervision.
17. There is a \$30.00 fee for any check returned for any reason.
18. Renter will be responsible for all costs to collect any unpaid bill, including all court costs, attorneys' fees, and 3<sup>rd</sup> party collection agency fees.
19. To carry and provide proof of renters' or non-owner insurance with a minimum liability coverage for our aircraft of \$5,000 before and through the duration of any flight.
20. To receive a flight release from an authorized Aerotech agent prior to the commencement of any flight. The flight release is the renter's permission to take the aircraft for a specific flight. To take an aircraft without a flight release is aircraft theft and criminal action may be enforced.
21. Renter will return hangar badges upon request and will pay Aerotech Aviation the cost owed to the Salt Lake Airport plus \$50 and any cost to collect those fees, including interest at 18%, 3<sup>rd</sup> party collection parties, attorney fees and court costs.
